Tá **Comhairle Contae Dhún na nGall** (dá ngairtear "**an tÚdarás Áitiúil**") anseo feasta) i ndiaidh Ordú dar teideal thuas a dhéanamh, agus tá sí ar tí é a chur faoi bhráid an Choimisiúin Phleanála, ag feidhmiú na gcumhachtaí a thugtar di le hAlt 76 d'Acht na dTithe, 1966, agus an Tríú Sceideal a ghabhann leis, arna leasú le hAlt 198 d'Acht na dTionóntachtaí Cónaithe, 2004, arna leathnú le hAlt 10 d'Acht Rialtais Áitiúil (Uimh. 2), 1960 (arna ionadú le hAlt 86 d'Acht na dTithe, 1966) arna leasú le hAlt 6 agus an Dara Sceideal a ghabhann le hAcht na mBóithre, 1993 arna leasú agus arna leasú le hAcht um Pleanáil agus Forbairt, 2000 arna leasú (lena n-áirítear Cuid XIV, ailt 213, 213(2), 222 de) agus de bhun fhorálacha Acht an Rialtais Áitiúil, 2001 (arna leasú).

Má dhaingnítear é, údaróidh an t-ordú don Údarás Áitiúil na tailte, lena n-áirítear a bhfostrataim, agus na cearta a thairiscítear i gCuid I, Cuid II, Cuid III agus Cuid IV den Sceideal seo a fháil go héigeantach, go buan nó go sealadach, chun críocha scéim cosanta tuilte Bhun na hAbhann a thógáil agus a chothabháil, mar aon le hoibreacha coimhdeacha agus iarmhartacha i mbailte fearainn Bhaile idir Dhá Abhainn, Charnashannagh, Monreagh (ar a dtugtar Barr of Kilmacilvenny fosta), agus Leibhéal na hInse, Contae Dhún na nGall.

COMPULSORY ACQUISITION OF LAND

DONEGAL COUNTY COUNCIL BURNFOOT FLOOD RELIEF SCHEME COMPULSORY PURCHASE ORDER 2026

Donegal County Council (hereinafter referred to as "**the Local Authority**") in exercise of the powers conferred upon it by section 76 of the Housing Act, 1966, and the Third Schedule thereto, as amended by section 198 of the Residential Tenancies Act, 2004, as extended by section 10 of the Local Government (No. 2) Act, 1960 (as substituted by section 86 of the Housing Act, 1966) as amended by section 6 and the Second Schedule to the Roads Act 1993 as amended and as amended by the Planning and Development Act 2000 as amended (including Part XIV, sections 213, 213(2), 222 thereof) and pursuant to the provisions of the Local Government Act 2001 (as amended), has made an Order entitled as above which is about to be submitted to An Coimisiún Pleanála for confirmation.

If confirmed, the order will authorise the Local Authority to acquire compulsorily, either permanently or temporarily, the lands, including the substrata thereof, the and rights described in the Schedule Part I, Part II, Part III and Part IV hereto for the purposes of the construction and maintenance of the Burnfoot Flood Relief Scheme together with ancillary and consequential works in the townlands of, Ballyederowen, Carnashannagh, Monreagh (aka Barr of Kilmacilvenny), and Inch Level, County Donegal.

The Commission cannot confirm-

- a compulsory purchase order in respect of the land if an objection is made in respect of the acquisition by an owner, lessee or occupier of the land, and not withdrawn,
- an order which authorises the extinguishment of a public right of way if there is an objection to the extinguishment, which is not withdrawn, until it has considered the objection(s), if any.

An Coimisiún Pleanála may at its absolute discretion, hold an oral hearing into the matter under section 218 of the Planning and Development Act 2000 (as amended).

Before making its decision on an application to confirm the Compulsory Purchase Order, An Coimisiún Pleanála must consider any objection made and not withdrawn, any additional submissions or observations made pursuant to a request by An Coimisiún Pleanála under section 217A of the Planning and Development Act (as amended), and any report of the person who held the oral hearing if such an oral hearing takes place.

The person conducting any oral hearing that may be held in relation to the Compulsory Purchase Order which relates to a development under section 175 of the Planning and Development Act 2000 (as amended) is entitled to hear evidence on the likely effects on the environment, the likely consequences for proper planning and sustainable development and the likely significant effects on a European Site.

A person may question the validity of any determination by An Coimisiún Pleanála to confirm a Compulsory Purchase Order by way of an application for judicial review, under Order 84 of the Rules of the Superior Courts as provided for in Section 50 of the Planning and Development Act 2000 (as amended).
